

# Aberdeen India Growth Fund



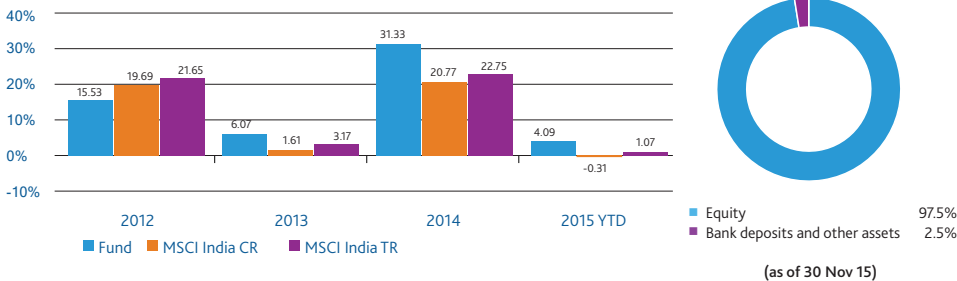
## Investment policy
